


The weighting system

- 41-60: Moderate performance; focus on enhancing strengths and addressing weaknesses
- **61-80**: Above average performance; continue refining processes and strategies for further improvement
- **81-100**: Excellent performance; maintain strong practices and seek opportunities for continuous growth and development

After completion of the assessment, an initial report is provided, highlighting the strengths and weaknesses of the organisation in each area. This feedback can be used to develop a roadmap for improvement and track progress over time. The report is designed to provide actionable insights, with specific recommendations for improvement.



Sample recommendations
